**REITERATION OF ENSURING A SAFE AND MOTIVATING ENVIRONMENT
AT PAMPANGA HIGH SCHOOL**

TO: All Teaching Personnel
All Non-Teaching Personnel
All Learners
All Other Concerned

1. With reference to DepEd Order No. 006, s. 2026 titled “Guidelines on Ensuring a Safe and Motivating Environment,” all school personnel and learners, as well as visitors get inside the premises of Pampanga High School are enjoined to observe the following school policies:

a. Bag Inspection

- a.1. All learners, school personnel, and visitors must submit their bags for inspection at the school gates upon request by the guard on duty to maintain a secure environment.
- a.2. **All teachers of the first subject in all classes must conduct bag inspection among all students before the start of classes. This process shall start on June 23, 2026.**
- a.3. All bag inspection should be conducted using authorized non-contact methods.
- a.4. All learners who will be found with deadly weapons and/or materials irrelevant to learning must be brought directly to the Office of the School Principal for questioning and further investigation.

b. Visitor Guidelines

- b.1. The NO ID, NO ENTRY policy shall be strictly imposed to all visitors. All visitors are required to present a valid identification card, surrender prohibited items for safekeeping, and ensure that no firearms should be brought into the school premises.
- b.2. All vehicles or motorcycles entering the campus are subject to a plain view inspection.
- b.3. For four-wheeled vehicles, the drivers are required to roll down all windows and open all compartments, including glove boxes and trunks for inspection.
- b.4. All drivers must present a valid driver’s license for

documentation.

- b.5. Motorcycle riders must remove their helmets and masks and open all onboard compartments for inspection.
- b.6. All visitors to be found with unnecessary or dangerous articles shall not be allowed to enter the school premises.

c. Prohibited Items

- c.1. Weapons such as firearms, daggers, and brass/iron knuckles, explosives and incendiary devices, hazardous chemicals, and illegal substance are prohibited inside the school premises.
 - c.2. Items that are irrelevant to learning and capable of causing disruption or harm, including common tools like hammer or razor blade, flammable materials like lighter and vape, or gambling and adult materials are also prohibited inside the school premises.
2. All learners and school personnel who will be found with prohibited items will be dealt with in accordance with the existing school rules and regulations and other statutes of the land.
